Disclaimers

The following disclaimers apply to the contents of the MPCA Internet Pages entitled “Enhancing Opportunities for P2 & Sustainable Activities at Remediation Sites,” hereinafter referred to collectively as the “Guidance.”

I. Guidance Is Not Exclusive and Lacks the Force And Effect Of Law

Minnesota Pollution Control Agency (MPCA) staff intends the policies and procedures in the Guidance to be used as guidance to evaluate the potential opportunities for pollution prevention (P2) and sustainable activities during investigation and cleanup of contaminated sites; to assist in choosing appropriate methods to implement P2 and sustainable activities at such sites; and to promote opportunities for P2 and sustainable activities at existing facilities or redevelopment at sites being remediated. These policies and procedures are not exclusive and do not have the force and effect of law. MPCA staff may use other policies or procedures to evaluate opportunities for P2 or sustainable activities at remediation sites. Application of these guidelines or procedures shall be site-specific, conducted if necessary in consultation with MPCA Site Remediation staff assigned to the specific site.

II. Reservation of Authorities

Implementation of P2 or sustainable activities suggested in the Guidance is wholly voluntary, and negotiated and consensual in the event the activity is included in MPCA assurances or approvals, with the exception of instances in which an activity is necessary to correct a violation of pollution control statutes or rules or necessary to prevent a threatened release from becoming an actual release. However, the MPCA reserves the authority to take any appropriate actions within its authority with respect to any release, threatened release, or other conditions at a site. The MPCA reserves the authority to take such actions if actions taken or omitted by a person with respect to a site contribute to any release or threatened release, or create an imminent and substantial danger to public health and welfare.

III. No Assumption of Liability

The MPCA, its Commissioner and staff do not assume any liability for any release, threatened release or other conditions at a site or for any P2 or sustainable activities undertaken at a site by any person, whether such actions are taken in accordance with the Guidance or otherwise.

IV. No Warranties

The MPCA, its Commissioner and staff do not warrant that any P2 or sustainable activity, or any product or service connected therewith, is suitable or appropriate for any particular purpose.

V. No Endorsement or Representations

Mention of trade names or commercial products in the Guidance does not constitute endorsement of particular companies, products or performance. References or World Wide Web links to non-MPCA sites do not imply MPCA endorsement of or responsibility for the opinions, ideas, data or products presented at those locations, or guarantee the accuracy, reliability or validity of the information provided.
