- For communities outside the U.S. interested in joining the international network
- Guides development of local AFV markets, giving the AFV industry confidence to enter the market
- Members must provide U.S. alternative fuel industry suppliers and manufacturers the opportunity to market their products
- Membership does not guarantee funding
- Members are eligible for assistance
 - Help to identify and secure funding from multinational donors
 - Technical assistance
