

Recycling

Recycling is one of many ways to reduce the amount of waste entering the landfill. Bins are available at the convenience sites and

landfill at no charge for anyone who wishes to recycle selected items. Please sort recyclable materials from your regular garbage. Commercial businesses are encouraged to take large volumes of recyclable items to the landfill.

Corrugated Cardboard – Corrugated cardboard only. Remove all packing and flatten boxes.

Plastic - Soft drink bottles and milk jugs only. Remove lids and rinse clean.

Aluminum - Beverage cans only. Rinse clean.

Newspaper - Newspaper print only. Remove all strings and bags.

Magazines - Remove all strings and bags. No phone books.

Glass - Bottles and jars only. Separate clear, brown and green colors. Remove lids and rinse clean.

The following items are prohibited from landfilling and must be removed from your regular garbage. Containers are provided at the sites to dispose of these items.

Tires - Limit 4 per week. Tractor tires and large truck tires are not accepted at the sites but are accepted at the landfill. User is responsible for unloading tires. **Appliances** - Limit 2 per week. User is responsible for unloading the appliance.

Lead Batteries - Limit 3 per week. Waste Motor Oil - Limit 5 gallons per week.

Decals

Decals are available strictly for Johnston County residential customers only. Each vehicle entering a convenience site or the landfill convenience site for garbage disposal must have a decal affixed to the vehicle. Commercial entities (including Mobile Home Parks) must dispose of garbage at the Landfill and pay a per ton disposal fee.

Household Decal - \$65.00 each

- Is for household garbage only. Limit one standard (1/2-ton) pickup truck load per week. Additional volumes may be taken to the landfill at a per ton disposal fee.
- If the decal is lost, stolen, vehicle sold, or the windshield replaced, the replacement cost will be full cost of the original decal.
- Decals are valid from July 1 through June 30.
- Decals are available only to Johnston County residents.

Decal Placement

- Remove any old County decals from your vehicle.
- Sit in the passenger seat of the vehicle.
- Peel the backing off the new decal.
- Place the decal onto the lower right corner of the front windshield.

Ordinance Violation

Any resident using the Convenience Centers to dispose of garbage without a decal is doing so against the Johnston County Solid Waste Ordinance. If the decal is not affixed on the vehicle's windshield, the site attendant is required to record the license plate number and document the incident as a violation of the ordinance. Civil penalties up to \$500 may be assessed for this violation. Introduction

In 1989, Johnston County developed a method for residents of the county to dispose of their garbage in a manner which is safe for the environment and more functional for its users. Since then, 12 manned "Convenience Centers" have been constructed to provide a means of recycling and disposing of solid waste. A clear understanding of the County's solid waste program will help minimize operating costs and make Johnston County a cleaner and more beautiful place to live.

Citizens who use the Convenience Centers to dispose of their garbage are required to purchase a decal annually and display it on their vehicle. The price of this decal covers a portion of the costs associated with operating the sites, transportation of waste, and landfill fees.

Special Rules

Some wastes are not acceptable at either the convenience centers or the landfill because of federal, state, or local laws. These items are as follows:

- All liquids
- > Fire, embers, or hot ashes
- > Hazardous wastes or unknown wastes
- > Poisons, herbicides, or pesticides

The following items are not accepted at the convenience centers and must be taken to the landfill.

- Dead animals
- Land clearing debris (trees or stumps)
- Large loads of waste
- Yard waste (logs, limbs or leaves)
- Shingles, construction or building material

* Yard waste is not accepted at the sites, but one standard (½-ton) pickup from a residence may be taken to the landfill under the decal. Limit 1 load per week.

* Decals do not cover shingles or construction waste disposal. Customers with construction or demolition waste must weigh at the landfill and pay a per ton disposal fee.

 All other items taken to the landfill are subject to a disposal fee.
